



On May 7th, the Community Foundation of Central Illinois hosted our 31st Annual Meeting. During the reception, the Estate of Jean M. Brown was honored as the 2019 recipient of the prestigious Founder's Award in recognition of the \$1.47 million donation that established the Jean M. Brown Scholarship Fund and the impact that fund has made on nursing students in central Illinois. The Founder's Award was established in 2003 to "recognize those organizations, corporations, and individuals who have so greatly contributed to our success". Past winners include Caterpillar, Gordon and Jean Peters, Gene and Harriett Swager, Donna Haerr, Jerry Horn, Ed Siebert, John Sahn, Pat Barton, and the Women's Fund of the Community Foundation of Central Illinois.

CFCI announced the largest donation in the Foundation's history. A \$16 million gift from the Human Service Center Foundation to the Community Foundation of Central Illinois will endow two restricted funds for long-term support of UnityPlace's work related to mental and behavioral health services in the community.

Additionally, Kim Keenan spoke on behalf of H.E.A.L. Food System Partners, who received the inaugural Ending Hunger Together grant of \$40,000. A quartet of students from Youth Music Illinois also provided entertainment during the program.

At the close of the 2017-2018 fiscal year, CFCI's assets totaled over \$37,000,000, held in nearly 490 funds within the Foundation and Depository accounts. We also continue to serve as a vehicle for effective distribution of charitable capital, awarding \$4,710,000 in grants to nonprofits in our community and beyond. At the heart of our mission is our passion for "Connecting People Who Care with Causes That Matter" and we are honored to support our community on behalf of our generous donors.
